**CHALLENGE 2010**

Thank you for entering the Quilters' Guild of NSW Challenge. The conditions listed below are fairly self-explanatory but please feel free to contact us at the guild office (as above) if you have any queries. The committee would like to encourage as many members as possible to enter, so please encourage others.

**CONDITIONS OF ENTRY**

- ◆ Entry is limited to individual members of THE QUILTERS' GUILD OF NSW INC.
- ◆ Any method of construction may be used but you must include ALL of the challenge fabric ON THE FRONT OF THE QUILT. Quilt must have 3 layers.
- ◆ The size of the finished quilt is to be **40cms x 60cms (16 x24 inches)** which may hang either way.
- ◆ A hanging sleeve must be attached to the back (sleeve to be at least 6cms deep).
- ◆ Each quilt must have a label securely attached to the back showing the quilt name and the quilter's name and address.
- ◆ Completed quilts are to be sent to the above address no later than **27<sup>th</sup> August, 2010**.
- ◆ Judges appointed by the committee will make awards for first and second.
- ◆ An award will be given for *Viewers' Choice*
- ◆ ALL quilts will be displayed at the Annual General Meeting of THE QUILTERS' GUILD OF NSW INC. to be held 16<sup>th</sup> September, 2010 at Burwood RSL
- ◆ A condition of entry is that ALL quilts will be retained by the Guild for inclusion in a Suitcase Exhibition, which will be available to groups on request. The quilts will be returned to the quilt makers at the completion of the exhibition (approx. 24 months)
- ◆ Whilst all due care will be taken, the Guild accepts no responsibility for the safety of the challenge entries. If you wish to insure your quilt, please make arrangements with your own insurance company.
- ◆ IF you wish to sell your quilt(s) you may put a price on your quilt (for sales purpose only). THE QUILTERS' GUILD OF NSW INC will receive a commission of 10% from the nominated sale price.
- ◆ The committee reserves the right to photograph, and permit to be photographed, all items for publicity, publication, and the Guild archives and for other appropriate purpose (this may include promotional stationery such as cards or bookmarks to be used as Guild fundraisers).

The quiltmaker must state the selling price, 10% of which will be retained by The Quilters' Guild of NSW Inc. as commission.

A non-refundable deposit, 20% of the sale price will be taken from the purchaser at the time of the exhibition. The quilt will not be released to the purchaser until the Suitcase Exhibition is completed and the final payment is made to The Quilters' Guild of NSW Inc. At this time the Guild will forward a cheque for the remaining 80% of the sale price to the quiltmaker.
